## MEMBERSHIP

Membership shall be opened to Malaysian citizens and non- Malaysian citizens above 21 years of age and to all who are interested in the objectives of MPBC.

### A. Categories of Membership

- 1) Ordinary Member
- 2) Corporate Member
- 3) Honorary Member

### B. Application requirements

- 1) Ordinary Member
  - a) Malaysian citizen or
  - b) An individual/expatriate who hold a valid visa issued by the Immigration Department of Malaysia
  - c) Copy of NRIC or Passport with valid visa page of applicant
- 2) Corporate Member
  - a) All applicants shall be corporations or organizations, including sole proprietor, enterprises, registered and incorporated in Malaysia
  - b) A copy of Form 9 / Form 13 and Section 58 (Form 49) for private or public company
  - c) A copy of Form E for sole proprietorship
  - d) Copy of NRIC or Passport with valid visa page of Member Representative
- 3) Honorary Member
  - a) Consists of a person who can make a generous contribution of financial contribution towards achieving the goals of The Council.
  - b) Such membership shall be nominated by the Committee and gets approval at annual general meeting.
- 4) Every application for membership shall be proposed and seconded by two existing members and shall be forwarded to the Secretary who shall at the first convenient opportunity, submit it to the Committee for approval. The Committee may at its discretion reject any application without assigning any reason thereof.
- 5) Every applicant whose application has been approved as aforesaid shall, upon payment of the prescribed membership subscription, be admitted as a member of the Council upon receiving an official payment receipt issue by the Treasurer and shall be entitled to all the privileges of membership.
- 6) Only valid membership members are eligible to vote and to hold office in the Council.

### C. Subscriptions and other dues

- 1) The membership year is from 1 January to 31 December. All subscriptions are due on first joining and thereafter annually on 1 January each year except that if a member joins on or after 1 July in any year membership shall continue for the whole of the following calendar year. If any member's annual subscription renewal remains unpaid by 27 February, membership will lapse.
